Report from South Leicester Community First Responders

South Leicester Community First Responders gave a presentation to Blaby District Council with the following surprising facts:

- ❖ All members are volunteers giving up their own time to provide a valuable service.
- ❖ It costs the group £2500 to fully equip each responder.
- ❖ Our main costs include our Defibrillator (AED) which is £1700 and our kit bag, including the pouches, costs around £320.
- ❖ We raise our funds independently to purchase our equipment, kit bags and uniforms.
- ❖ We attend a variety of jobs, such as:
 - Cardiac arrests
 - Major trauma
 - Mental health concerns
 - Emergency medical conditions
 - Generally unwell patients
- ❖ There are over 30,000 out of hospital arrests every year
- ❖ East Midlands Ambulance Service (EMAS) cover 6,425 square miles with only 2,700 staff members.
- ❖ EMAS respond to over 616,236 999 calls a year, which is why our job is so important.
- ❖ OCTOBER REPORT
 - 250+ volunteered hours
 - 72 call-outs
 - 4 Cardiac Arrests
 - 17 Breathing Difficulties
 - 9 Chest Pains
 - 4 Seizures
 - 5 Off-Duty Alerts

Tritax are expected to submit the HNRFI application to the Planning Inspector during January 2023. The process will then take approximately 18 months before a decision is made by the Secretary of State.

MPs raise Rail Freight Hub concerns with Transport Secretary

Leicestershire MPs Alberto Costa and Dr Luke Evans have written to the Transport Secretary to reiterate their concerns over the proposals for the Hinckley National Rail Freight Interchange (HNRFI) with the formal planning application expected to be submitted early next year.

Mr Costa, MP for South Leicestershire where the site would be located near the village of Elmesthorpe, has previously raised the planned rail hub in debates in Parliament, and has been supported by Dr Luke Evans, MP for Bosworth, whose constituency borders the proposed site.

In their letter to the Secretary of State for Transport, The Rt. Hon Mark Harper MP, the MPs expressed their concern over the rail hub's environmental impact on nearby Burbage Common, a site of Special Scientific Interest, the site's effect on local infrastructure with 8,000 people expected to be employed at the hub, and the potential disruption for passenger train services at nearby Narborough station with one-mile-long freight trains expected to service the new interchange.

Both MPs have also previously issued surveys to their constituents in South Leicestershire and Bosworth seeking local views on the rail hub's impact, with Mr Costa planning a further survey in the New Year.

Mr Costa said, *"With the planning application for the Hinckley National Rail Freight Interchange (HNRFI) expected to be submitted early next year, I am pleased to once again be working closely with Dr Luke Evans MP, my constituency neighbour, in making strong representations to the Transport Secretary over our constituents' concerns."*

"As I have mentioned in Parliament previously, the sheer size and scale of the proposed Rail Hub could have a hugely detrimental impact on our local environment and infrastructure in this part of Leicestershire, and therefore the Government needs to be made aware of the considerable concerns my constituents, and those in Bosworth, have over these plans before taking any decisions."

Dr Luke Evans added, *"Following news that Tritax have concluded the consultation into the viability of a Rail Freight Interchange in Hinckley I have also written to the developers to request a list of any amendments made to the proposals previously shared with us. While lowering the maximum height of the building from 33m to 28m is welcome, many questions from our community regarding the strain on transport links remain unanswered."*

Alberto and I will continue to work together on this, ensuring the Government are aware of the concerns raised by many people across both Bosworth and South Leicestershire about the impact this will have on our infrastructure and the local environment, particularly our wonderful Burbage Common"
