# i) S137 EF advised the following:

The Department for Levelling Up, Housing and Communities (DLUHC) has notified the National Association of Local Councils (NALC) that the appropriate sum for the purpose of section 137(4)(a) of the Local Government Act 1972 (the 1972 Act) for local (parish and town) councils in England for 2022/23 is £8.82 per elector.

This is the amount as a result of increasing the amount of £8.41 for 2021/22 by the percentage increase in the retail index between September 2020 and September 2021, in accordance with Schedule 12B to the 1972 Act.

We are therefore able to spend up to £5,177.34 under this authority - **Noted** 

ii) EF confirmed receipt of BDC service agreement for litter/dog bins.
