Net Zero

Blaby District Council is committed to achieve net zero as an organisation by 2030 and to support the district in becoming net zero by 2050. Helping communities to install solar panels will increase energy independence, reduce carbon emissions and lower energy bills.

Solar Together Leicestershire is an innovative new scheme offering high-quality solar photovoltaic (PV) panels and battery storage. It is a group-buying scheme, which brings Leicestershire households together to get high-quality solar panels at a competitive price.

Blaby District Council is leading a partnership with neighbouring councils and independent experts in group-buying, iChoosr Ltd, to bring this opportunity to Blaby District's homeowners, launching on 9th May 2022. The aim is to achieve at least 300 installations countywide which would save around 300tCO2e/year and over £1.3m invested in the green economy.
